Moved by Mrs. Dziedzic supported by Mrs. Meck to approve the wage recommendation for Classroom Aides:

- a. All new classroom aides will start at \$14 an hour. If they have a successful first 30 days of employment, they will be notified that their hourly rate will increase to \$15 an hour.
- b. All existing aides will be given a \$1.00 an hour increase in hourly rate.
- c. Aides will receive a \$2.00 increase per their regular hourly rate when working in the SCI classroom.
- d. If a classroom aide takes a sub or permanent job as a transportation aide they will receive a \$2.00 increase per their regular hourly rate.
- e. Increase the sub aide rate from \$12.15 an hour to \$13 an hour.
